## Course Summary

Once the candidate is registered, after the profile and induction visit, they will be able to apply for a one year trade CSCS card extension. Once they have completed their NVQ their card will then last five years but is simply renewed by a Construction Skills touch screen health and safety test and will run for a further five years. A CITB grant from 400 to 488 is available for companies registered with the Construction Industry Training Board. Delegates should inform their trainer if they have any serious health issues, physical problems, special considerations or are taking any medication, which may create difficulties in undertaking elements of this training course. Duration: The duration of a Level 3 NVQ varies depending on the candidate, their level of experience and the work they are undertaking. We advise that the majority of NVQ Level 3's are completed between 6 and 9 months from induction.

## Who Attends

Any person or employee, that works as a foreman or in a supervisory capacity and needs to obtain a CSCS card and a nationally recognised qualification in this trade. The candidate must have previously successfully completed a Supervisor's Health and Safety touch screen test within the past two years.
